The proponent is currently preparing its Terms of Reference, which will provide the framework for the preparation of the EA. The Terms of Reference, if approved, will set out the framework for meeting the requirements of Ontario's Environmental Assessment Act. The proponent will be required to consider a broad range of potential environmental effects.

For areas of commonality between the provincial and federal requirements, the ministry encourages the proponent to ensure both sets of requirements are met in the EA report and to seek ways to find efficiencies in meeting the requirements (e.g. technical studies, consultation). It is expected that ongoing guidance toward achieving efficiency and coordination in the review of the proponent's EA-related studies will be necessary.

Under the Ontario Environmental Assessment Act, the proponent is required to consult with interested persons, including Indigenous communities, the public, and government agencies, as it prepares the terms of reference and environmental assessment. The proponent has recently initiated a 30-day public, Indigenous and agency comment period on its draft Terms of

Reference, ending October 16, 2019. Once the final Terms of Reference is submitted, there will be a regulated 30-day public, Indigenous and agency comment period.

If the Terms of Reference is approved, there will be additional comment opportunities during the EA process, including proponent-led consultation during the preparation of the EA as well as regulated 7-week and 5-week comment periods. The timing of this is presently unknown.

No. The Ministry of Energy, Northern Development and Mines is administering a funding program for this project.

In particular, should the Terms of Reference be approved, the ministry encourages the proponent to ensure both sets of requirements are met in the EA report and to seek ways to find efficiencies in meeting the requirements (e.g. technical studies, consultation). It is expected that ongoing guidance toward achieving efficiency and coordination in the review of the proponent's EA-related studies will be necessary.

b. Do you intend to delegate the duty to consult to the proponent during the EA?

Ontario has a constitutional duty to consult Aboriginal communities whose Aboriginal or treaty rights may be adversely affected by a project before it makes any decisions on that project. In the case of the Webequie Supply Road project, Ontario is working with the proponent to develop an approach that sets out the sharing of procedural aspects of that responsibility with the proponent.

Under the Environmental Assessment Act, the proponent must also consult with interested communities as it prepares the Terms of Reference and EA and will coordinate that consultation with the procedural aspects of the duty to consult, where appropriate.

The proponent signed a voluntary agreement to subject the project to an individual EA under the Ontario Environmental Assessment Act. The proponent is required to meet the requirements of the EAA and follow the Codes of Practice for preparing the Terms of Reference and EA as well as consultation, which can be accessed at <https://www.ontario.ca/page/preparing-environmental-assessments>.

The proponent anticipates requiring permits and approvals from MECP including permit to take water under the Ontario Water Resources Act, permit under the Endangered Species Act and Environmental Compliance Approvals under the Environmental Protection Act. This information will be further confirmed by the proponent during the EA and post-EA permitting phases.
