Fisheries and Oceans Canada, Fish and Fish Habitat Protection Program, has reviewed the available project information. Based on this information, as proposed, the Project may result in the harmful alteration, disruption or destruction of fish habitat and/or the death of fish and may require authorization under the *Fisheries Act*.

The report provided does not provide sufficient information to assess impacts to Smoky River from the water withdrawal. Clarification is needed on the following:

- Description of fish and fish habitat in the watercourses and how the habitat will be impacted by changes in flows.
- Impacts to fish due to waterbody and wetland crossings during transmission line installation.
- Impacts to Species at Risk and sensitive species, namely Bull Trout and Arctic Grayling, in the Smoky River.
- Will additional water be withdrawn, and/or will the new/amended license permit additional/increased withdrawals? Proponent should provide further clarification on the daily water withdrawal from the existing source location (i.e., Is 32.8 m³/day the total or in addition to the existing licence?).
- Is there potential for impingement and/or entrainment into the existing facility, and potential increase to impingement and entrainment as a result of increased water withdrawals?
- How does the existing and additional withdrawal volumes compare to DFO's Framework for Assessing the Ecological Flow Requirements to Support Fisheries in Canada (2013)? Proponent should provide additional information regarding other users on the Smoky River and cumulative impacts of flow withdrawals on fish and fish habitat.
- Information on the return and run-off water outlet and potential impacts on fish and fish habitat (e.g. potential to introduce warm water to a cool/cold water system).

It is DFO's opinion that without mitigation measures, this project may result in adverse effects to fish and fish habitat.
