Dear Leila Boussaïd:

On February 10, 2020, the Honourable Steven Guilbeault, Minister of Environment and Climate Change determined that a regional assessment (RA) will be conducted in an area centred on the Ring of Fire mineral deposits in northern Ontario. The planning phase of the RA has been in progress since that time and has focused on building Indigenous relations, collaboration with the Province of Ontario and engaging with federal authorities.

In January 2023, the Minister met with Indigenous leaders and committed to a co-led process between the Impact Assessment Agency of Canada (the Agency), Indigenous groups who have traditional territory in the region, and potentially the Province of Ontario. Dialogue focused on the best means of advancing relationships and co-developing a Terms of Reference that reflects the priorities of Indigenous communities and the federal and provincial governments. (See Letter from Minister for further details.)

Working group meetings are now underway between the Agency and Indigenous partners, with the Province of Ontario currently attending as an observer. The objective of the working group is to develop a co-led process, with the goal of a finalized co-developed Terms of Reference in early 2024.

On December 7, 2020, in accordance with section 100 of the *Impact* Assessment Act, the Agency requested input from federal authorities to inform the design of the RA process, as well as outline their mandate and

areas of expertise, including regulatory authority, expert knowledge, and on-going programming in the Ring of Fire area. Responses received are available on the <u>Canadian Impact Assessment Registry Internet site</u> (the Registry). In order to ensure that the Agency records are up to date, we are requesting that federal authorities provide an update to the original Federal Authority Advice Record (Annex 1).

Please ensure that your designated official responds to the items detailed in the attachment to this letter by November 20, 2023. Any additional information not specified in the attachment may also be provided. Your response will be posted on the Registry. Note that, all records produced, collected, or received that are relevant to the RA will be posted on the Registry unless they are excluded for privacy or security reasons, or are determined to be otherwise protected or excluded.

Thank you in advance for your department's continued participation in planning the RA in the Ring of Fire area. You will be contacted at a later date about opportunities for involvement in the on-going planning and eventual conduct of the RA.
