There are many sources of information that could be used to gain navigation information and types of boats etc. on a given waterway, such as (not exhaustive list): input by local Indigenous communities; cottager affiliations; charted waterway maps; boating affiliations; local marinas; chartered boating and/or fishing companies; duck hunting clubs; etc.	Recommend that navigation be included in Section 7.2.
Transport Canada - 02	9.2.2- Navigation	This section is still a bit vague as to the details TC requires as per the Canadian Navigable Waters Act (CNWA), and which should ultimately be covered in the EIS.	Information regarding any Minor Works, Works or Major Works in, on, over, under, through or across navigable waterways should be included in the guidelines. These may include bridges, culverts, aerial cables, causeways, water intakes, outfalls, etc. We note that the draft Permitting Plan explains these information requirements well (that we mention above).
