#### Enclosure 1: Summary of Information on Potential for Impacts on the Métis Nation of Ontario from the Northern Road Link Project

This **draft** document was prepared by the Impact Assessment Agency of Canada (the Agency) to set out the Agency's preliminary understanding of the **potential** for impacts on the Métis Nation of Ontario, due to the Northern Road Link Project (the Project). The Agency is seeking to learn about direct impacts the Project could have on the exercise of the Métis Nation of Ontario's Aboriginal rights. There are prompting questions in this document, which the Agency hopes could guide your input to the Agency. The Tailored Impact Statement Guidelines for the Project will identify the valued components that the Proponent will be required to study during the preparation of its Impact Statement.

As additional information about impacts of the Project that are specific to the Métis Nation of Ontario are shared with the Agency throughout the impact assessment process, this document will be updated, and will inform the Proponent's studies and the impact assessment.

#### The Proposed Project

Marten Falls First Nation and Webequie First Nation (the Proponent) is proposing the construction and operation, including maintenance, of an all-season multi-use public highway approximately 117 km to 164 km in length. The highway would connect the proposed Webequie Supply Road to the proposed Marten Falls Community Access Road. The highway would become part of a future all-season road network connecting mineral development activities in the Ring of Fire area to the provincial highway network system at or near Nakina, Ontario.

Summary of Information Available to the Agency about:

- a) the nature and extent of the Métis Nation of Ontario's Aboriginal rights;
- b) potential for impacts from the Project on the exercise of the Métis Nation of Ontario's Aboriginal rights; and
- c) potential changes to health, social, or economic conditions of the Métis Nation of Ontario due to the Project.
- a) Summary of the information available to the Agency related to the nature and extent of the Métis Nation of Ontario's Aboriginal rights:
  - Members-Citizens of the Métis Nation of Ontario have Aboriginal rights that are recognized and affirmed under section 35 of the Constitution Act, 1982.
  - The known extent of the Métis Nation of Ontario's Lakehead/Nipigon/Michipicoten
     Traditional Territories are located approximately 175 km south of the Project. The rights-bearing citizens who exercise section 35 rights within the Traditional Territories, are part of the recognized and asserted Northern Lake Superior Historic Métis Community, which is represented through elected leadership via the Region 2 Consultation Committee.
  - The Agency has been informed that the Métis Nation of Ontario does not anticipate direct impacts to there will be no impacts to the section 35 Aboriginal rights of the Métis Nation of Ontario Region 2 as a result of the Project.
  - The Métis Nation of Ontario Region 2 clarifies that it makes no assertions of rights within the Project study area at this time. However, the Métis Nation of Ontario wishes to be engaged regarding regional and cumulative effects of the Project that could have potential jndirect impacts to the Métis Way of Life within the known Traditional
