#### Subject: Designation Request for the Proposed Ontario Place Underground Parking Garage under the Impact Assessment Act

On September 18, 2023, the Minister of Environment and Climate Change (the Minister) received a request to designate the proposed Ontario Place Underground Parking Garage (the physical activity / activities referred to as the Project) under subsection 9(1) of the Impact Assessment Act (IAA).

### The Proposed Project

The Project would be located near Toronto, Ontario. The Project involves the construction and operation of an underground parking garage, which would be located beneath the proposed relocated Ontario Science Centre on the mainland near Ontario Place. The Project as proposed is not a designated project as described in the *Physical* Activities Regulations.

### **Designation Request**

Under subsection 9(1) of the IAA the Minister may, by order, designate a physical activity that is not prescribed in the *Physical* Activities Regulations. The Minister may do this, if, in the Minister's opinion, the physical activity may cause adverse effects within federal jurisdiction or adverse direct or incidental effects (resulting from federal decisions, including funding), or public concerns related to those effects warrant the designation. In accordance with subsection 9(4) of the IAA, it is expected that the Minister will respond, with reasons, to the request by December 27, 2023.

However, as per the limitation of subsection 9(7) of the IAA, the Minister must not make the designation if (a) the carrying out of the physical activity has substantially begun;<sup>1</sup> or (b) a federal authority has exercised a power or performed a duty or function conferred on it under any Act of Parliament, other than the IAA, that could permit the physical activity to be carried out, in whole or in part.

The Impact Assessment Agency of Canada (the Agency) will review information to determine whether substantial physical works have begun, or if a federal authority has exercised a power or performed a duty or function under an Act of Parliament other than the IAA.

The Agency will review information about the Project; any concerns expressed from the public (that the Agency is aware of) and Indigenous communities; expert advice from federal authorities and input from provincial ministries in order to inform the Minister on whether the Project should be designated.

If the Project were to be designated, in order to proceed with the Project, Infrastructure Ontario would be required to submit an Initial Project Description to the Agency, thereby commencing the planning phase under the IAA. In this case, the planning phase would include the Agency determining whether a federal impact assessment is required.
