EPEA Approvals – A technical review of the application considers releases and its potential impact to the Environment and close by receptors. For e.g. the air emissions to the atmosphere may include nitrogen oxides, particulate matter, ammonia slip and any other potential parameters of concern potentially be part of the technical review process. Since the gas turbine will only consume natural gas, particulate matters emission to the environment will not be a concern.

- Air section regulating air emissions.
- Wastewater section regulating runoff control.
- Waste management section regulating waste storage and disposal.
- Domestic wastewater section regulating disposal of domestic wastewater.
- Groundwater section requiring groundwater monitoring.
- Soil section requiring soil monitoring.
- Decommissioning section regulating decommissioning and reclamation activities.

Alberta Arts, Culture and Status of Women - The proponent has applied for, and has received, *Historical Resources Act* Approval for this project under Alberta Arts, Culture and Status of Women file no. HRA #4940-23-0013-001 (February 16, 2023).

Public Lands Disposition Management - An application referencing the Black Bear Power Project was submitted in 2023 and approved under Miscellaneous Lease DML230030. The plan associated with the Stockpile is tied to disposition # DML230058.

EPEA - Notice of Application under EPEA is mandatory public consultation for any new applications where potentially directly affect public members have an opportunity to submit their concerns.

The Indigenous Relations group lead the First Nation Consultation (FNC) assessment adequacy requirement and are responsible from start to finish consultation process.

Water Act - A Notice of Application (7 day for approvals and 30 -day for licences) is mandatory public consultation for any new applications where potentially directly affect public members have an opportunity to submit their concerns.

• First Nation Consultation (FNC) assessment adequacy is a mandatory part of the application review process under the *Water Act*.
